I/we further understand and agree that this hold harmless and indemnification shall apply to any and all facilities that the **California Line Dance Association of America**.

Should any dispute arise which we are unable to resolve through negotiation or the use of third-party mediation, the undersigned agree to submit to resolution by arbitration in accordance with the rules of the American Arbitration Association.

IN AGREEING TO ARBITRATION, WE BOTH ACKNOWLEDGE THAT IN THE EVENT OF A DISPUTE OVER FEES, EACH OF US IS GIVING UP THE RIGHT TO HAVE THE DISPUTE DECIDED IN A COURT OF LAW BEFORE ANY JUDGE OR JURY AND INSTEAD ARE ACCEPTING THE USE OF ARBITRATION FOR RESOLUTION. The prevailing party shall be entitled to the allowance of a reasonable attorney's fee and other costs of such action. **California Line Dance Association of America** reserves the right to cancel your membership if you interfere with the interests of this organization. Lease takes good care of your personal belongings, because **California Line Dance Association of America** is not responsible for the loss of personal belongings of its members and their guests. This membership is non-transferable, and it has to be renewed annually. There will be a \$ 5 charge for the reissuing of lost membership card, and there will also be a charge of \$15 for bounced check.
